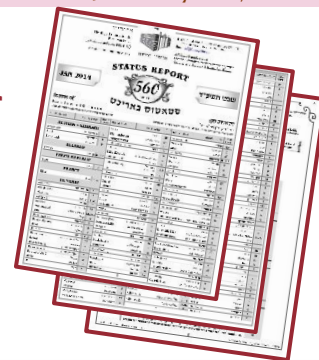

Announcement from the Maintenance Division

Dear Descendants,

With admiration and thanks to your cooperation so far, which facilitated the restoration and preservation of your ancestral cemetery, we hereby approach you regarding the upcoming maintenance season.

It's needless to elaborate on the importance and effectiveness of the maintenance program, which designates periodic cuttings followed by **personal** visits to the cemetery. From experience, this system is the way to **ensure the continued existence of the cemetery.**

Over the years, difficulties to collect the minimal fees for the expenses involved grew beyond the limits of Avoyseinu. Therefore we are presenting here the following options for maintenance:

- Option A: Greatly Recommended**
The family should arrange maintenance with the caretaker on their own. Please note that in order for the maintenance to be effective, **there must be at least four annual cuttings in the cemetery, followed by personal inspections.**
- Option B: Offered due to popular demand**

Avoyseinu can continue coordinating the maintenance on the following conditions:

- The families will need to pay up all maintenance fees for the following five years, along with a payment for the complete outstanding balance. The money will be entered in a separate maintenance account.
- Avoyseinu will thereafter draw up a contract with the caretaker for the following five years. The benefits of such a contract are manifold: the cemetery becomes a project for the caretaker, who can be properly trained on the job, after which the work is done with more devotion and experience. In addition, Avoyseinu's inspector also develops a personal relationship with the caretaker, which is extremely constructive.
- Option C: Special exception**
The cemeteries where the expenses are paid regularly, without Avoyseinu's intervention, will continue being under the regular maintenance plan.
