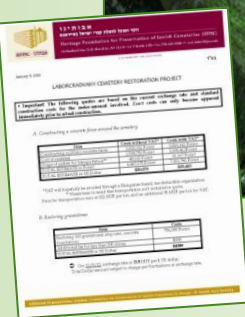
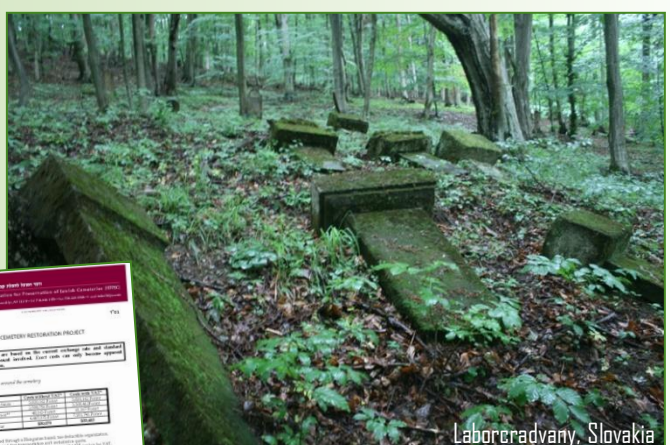

Maintenance Contract

Between Avoyseinu, referred to as Party A,
 and Descendants' Representative _____, referred to as Party B.

We the undersigned agree to the following:

- Party A** agrees to arbitrate between the descendants and the cemetery caretaker, and will appoint a reliable person to cut the cemetery periodically.
- Party A** will personally inspect the caretaker's work by visiting the cemetery, forging a personal contact with the caretaker which strengthens the supervision on the cemetery.
- Party A** will send a report with photos of the cemetery's situation to **Party B** after each visit.
- Party B** agrees to pay the requested maintenance fee of \$ _____, which includes caretaker's wage and Avoyseinu related overhead. Payment can be made through legitimate head-checks and CC according to the following dates:

25% in the amount of \$ _____ - paid by January 25, 2013
 25% in the amount of \$ _____ - paid by March 12, 2013
 And remaining 50% \$ _____ - paid by May 10, 2013

• The above includes the routine fees of the caretaker and the administrative maintenance costs. Understandably, unforeseen costs as in reparations etc., will be covered by **Party B**.

5. Both Parties must arrange a valid method of payment for any previous balances when signing **this contract**.
