We the undersigned agree to the following:

1. Party A agrees to institute a supervision at the cemetery by appointing a caretaker for the site. The grounds will be cut at four designated times.
2. After each cutting, Party A will dispatch an agent to inspect the work, forging a personal contact with the caretaker. Photos of cemetery will be sent to Party B.
3. Party B agrees to pay the requested maintenance fee which includes caretaker's wage and Avoyseinu's related overhead. \$ ___ must be paid by -/-/- and \$ ___ by -/-/-. Legitimate head-checks and CC payments will also be accepted.
4. Payment for a previous balance must be arranged when signing this contract with a valid method of payment.

Important Alert For Maintenance Year 2012

Due to various reasons, a letter will be sent out to all descendants regarding the new arrangements for maintenance of year 2012.

- A representative (one family member on behalf of all descendants) will have the opportunity to sign a contract by January 15, 2012 where all details for the maintenance will be arranged.
- Avoyseinu provides a private contract to arrange the share of payment between all family members.
- For all who have paid in advance, the above isn't applicable.

Cemeteries in which a contract has not been signed, will be excluded from the system.
